KNOW ALL MEN BY THESE PRESENTS:

That we, Scott G. Stubbs, Miller Wm. Meredith, R.K. Minton, O. Joseph Damiani, and
Robert E. Lewis,

all citizens of Texas, under and by virtue of the laws of this state, do hereby
voluntarily associate ourselves together for the purpose of forming a private
corporation under such laws, upon the following terms and conditions:

FIRST

The name of the corporation shall be Robindell Recreation Association

Second

The purpose for which this corporation is formed is the operation of a
swimming and social club, as authorized by subdivision 9 of article 1302 of
the Texas Revised Civil Statutes.

Third

The principal office and place of business of this corporation shall be
at its office in Harris County, Texas, Robindell Subdivision approximately
2 1/2 miles West of Bellaire, Texas, and its mailing address shall be
6120 Beechnut, Bellaire, Texas

Fourth

This Corporation shall exist for a period of fifty (50) years unless
sooner dissolved.

The number of directors shall be 12 but such number may be increased
or diminished in accordance with the By-Laws, such number however, never to be

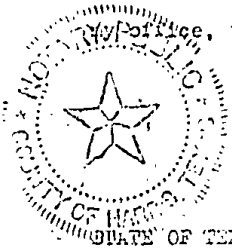
