- 8. The amount and description of a fee or fees charged by the association relating to a property transfer in the subdivision is \$375 for a Resale Certification.
- 9. An Initiation Fee equal to 12 months of Lake Kiowa POA applicable monthly dues is administered and due at the time of closing for purchase of any lot or property. If the fee is not collected in the closing of the property by the title company, the fee will be added to the new member's bill / monthly statement. See Initiation Fee Policy for additional information, including situations in which the fee may not be applicable to existing members. Note: fee is subject to increase annually to coincide with yearly dues increases, as applicable.
- Other information the association considers appropriate. Monthly dues are \$307.60 as of 01/01/2024 and are subject to a potential increase each year, this includes full use of all amenities, there is no charge for playing golf if you are a member or lessee to include dependent children living with their parents and age 18 and under or full-time college students under the age of 25.

The Lake Kiowa Property Owners Association is a 1,700-acre, rural, gated community, consisting of 1,462 owners, is surrounded by ranches, and located about 13 miles SE of Gainesville, TX and 35 miles north of Denton, TX. Its population ranges in the 2,000's with about 25% of the owners being part-time residents. No lots are currently available from the Association. The Association has about 52 acres that are undeveloped for future amenities. Current amenities include a 563-acre lake with docks allowed if lakeside property is owned and offers a private marina and great fishing. The Association has an 18-hole golf course and pro shop, putting green and driving range, two beaches, a lodge with dining and a tavern along with meeting rooms for various events and a new lake side pavilion for larger events. Lake Kiowa

has 3 walking trails, 2 playgrounds for children, 3 boat ramps and our own Public Works Department that cares for our 22 miles of roads and several parks. We have full time Security that controls the 2 entrance gates and patrols the property 24 hours a day. This is a casual, mixed age, mixed income community that has several events, clubs, and gatherings. Lake Kiowa is served by an onsite volunteer fire department and is served by Lake Kiowa Special Utility District for water. We are part of the Callisburg School District and are about 15 miles from North Central Texas College and 35 miles from the University of North Texas and the Texas Woman's University.


