The annual assessment may be split into two payments; one due in January and one due in June. For those who elect one payment, the assessment is due on January 1st and is delinquent on January 21st. For those who elect two payments, the first installment is due on January 1st and is delinquent on January 21st. The second installment is due on June 1st and is delinquent on June 21st. Payments which are delinquent will be assessed a late fee of \$10 per month for each month in delinquent status.
