ARTICLES OF INCORPORATION

OF

# PAREWOOD SUMMIT CONDOMINIUMS HOMEOWNERS ASSOCIATION

The undersigned, a person of the age of eighteen (18) years or more and a resident of the State of Texas, acting as the incorporator of a corporation (hereinafter called the "Corporation") under the Texas Non-Profit Corporation Act, does hereby adopt the following articles of incorporation for the Corporation:

# ARTICLE I

The name of the Corporation is PARKWOOD SUMMIT CONDOMINIUMS HOMEOWNERS ASSOCIATION.

### ARTICLE II

The Corporation is a non-profit corporation.

## ARTICLE III

The period of its duration is perpetual.

# ARTICLE IV
