

**MANAGEMENT CERTIFICATE FOR

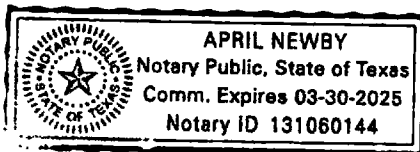
