Updated Resale Certificate: \$75 to produce an updated resale certificate. Applicable only if the request is made less than 180 days of the issue date and by the same party who requested the original resale certificate.

- 8. Additional information the Association considers appropriate are as follows:
 - a. Membership in the Association is mandatory, and all owners shall comply strictly with the provisions of The Woodlands Restrictions and Bylaws. Owners are advised to review the dedicatory instruments given to them at closing or emailed to them by the HOA Secretary.
 - b. No improvement shall be constructed on any lot without written prior approval from The Woodlands Architectural Review Committee. Any violation is subject to monetary penalties.
 - c. It is the responsibility of any homeowner renting their property to make sure the tenants are aware of all requirements and rules according to the dedicatory instruments. If they are found in violation of any of the restrictions and bylaws, the homeowner will be assessed the monetary penalties.
