Capitalization Fee [Declaration Article IV, Section 4.10]	Each Owner (other than Declarant) who purchases a lot will pay a one-time initial contribution to the Association which amount will be due immediately upon the transfer of title to the lot. Upon the purchase of a lot from Declarant, the Capitalization Fee is \$1,000.00. Upon each subsequent sale of a lot, the Capitalization Fee will be determined by the Board. Some exemptions apply. The Capitalization Fee amount must be confirmed with the Association.

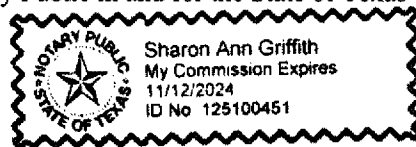
