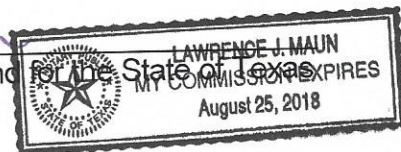

AMENDMENTS TO BY LAWS


At a Special meeting of the Members of Townhouse Manor Inc., held November 14, 2017, at which a quorum was constituted, the following Amendments to the By Laws of Townhouse Manor, Inc. were approved by a majority of Members of Townhouse Manor, Inc.:

Article II, Section 2 of the By Laws is Amended to read as follows:

SECTION 2. Annual Meeting. The annual meeting of the membership shall be held during the month of January each year on a date and at a time as designated by the Board of Trustees for the purpose of electing Trustees and for the transaction of such other business as may come before the meeting. The day scheduled may not be held on a day designated as a legal holiday in the State of Texas. If the election of Trustees shall not be held on the day designated herein for any annual meeting of the membership or at any adjournment thereof, the Board of Trustees shall cause the election to be held at a special meeting of the member, as soon thereafter as convenient.

Article III, Section 2 of the By Laws is Amended to read as follow:

SECTION 2. Number, Tenure and Qualifications. Until January 1, 1969, the Trustees of the corporation shall be those named in the Articles of Incorporation. Thereafter, the Board of Trustees shall be composed of five (5) Trustees who shall be the residential owner and occupant of a lot in Townhouse Manor; and each such Trustee shall be elected at an annual meeting of the members or at a special meeting of the members called for such purpose and shall hold office until the next annual meeting of the members at which time his/her term expires. Trustees shall serve two (2) year terms with a limit of three (3) consecutive terms, except in the first year this amendment is in effect, in which three (3) Trustees will be elected to two (2) year terms and two (2) Trustees will be elected to a one (1) year term. Thereafter, all trustees will be elected to two (2) year terms. All Trustees shall hold office until their successors have been duly elected and qualified.
