

      - 1. Vacant lot ownership, \$124.00 per month.
      - 2. Home Ownership, \$222.00 per month.
      - 3. If purchasing a property in Lakeview, Golfview, or Water's Edge, there is an additional fee of \$45.00 per month for lawn maintenance.
